

Tuition fees at the Faculty of Civil Engineering

General rules

- The tuition fees are included in the Tuition Fee Table.
- The *tuition fee for one semester* is determined by assuming that in each semester the Student registers for subjects of 30 credits in average, all of which are included in the Curriculum of the Course.
- The tuition fee is to be paid before the registration for the actual semester.
- This regulation is effective from the 2nd semester of the 2011/12 academic year.

Specific rules for payment in parts

- Upon a specific request, the Student might get a permission to pay the tuition fee in two parts.
- The first part is to be paid before the registration, and the first part of the tuition fee cannot be less than the *minimal tuition fee for one semester* (as defined in the Tuition Fee Table).
- The deadline for the payment of the second part of the tuition fee is determined by the decision on the request, but this deadline must precede the registration week of the subsequent semester.

Specific rules for tuition fee reduction

- If the actual number of credits taken by the Student in a semester is less than 24, tuition fee reduction is possible. The tuition fee reduction is determined by the Faculty, upon a special request made by the Student.
- The tuition fee reduction is considered in the subsequent semester provided that the student has an active status in the subsequent semester in the same Course.
- The reduced tuition fee cannot be less than the *minimal tuition fee for one semester* (as defined in the Tuition Fee Table).
- The reduction of the tuition fee is determined on the basis of the credit fees in the Tuition Fee Table.

Specific rules for extra tuition fees

- If the actual number of credits taken by the student in a semester is more than 36, an extra tuition fee must be paid. The extra tuition fee is determined by the Faculty on the basis of the credit fees in the Tuition Fee Table.
- If the Student registers for a subject not included in the Curriculum of the Course, an extra tuition fee must be paid. The extra tuition fee is calculated as the (*number of extra credits*) × (*fee for one credit in regular course*).
- If the Student registers for a subject (included in the Curriculum of the Course, in regular course) in a cross-semester, an extra tuition fee must be paid. The extra tuition fee is calculated as the (*number of cross-semester credits/hours*) × (*fee for one credit/hour in regular course*).
- Any extra tuition fee is considered as part of the tuition fee for the actual semester.
